# Narrative #1: The "Who Am I Now and Here?" Essay 2016

Playwright Oscar Wilde quipped, "Education is an admirable thing, but it is well to remember from time to time that nothing that is worth knowing can be taught."

Another great British writer, Thom Yorke of Radiohead asks "What the hell am I doin' here?/I don't belong here."

As you likely noticed, questions of identity and environment fueled our summer reading texts. These narratives present protagonists struggling to understand who they are and who they can become. In these novels, the narrators labor to understand the influence of place upon identity and the importance of clearly considering critically the opinions of external authorities eager to impose their ideas upon the identities of the young.

We tend to believe that unfamiliar narratives can drive us to a better, deeper understanding of what it means to be human while also leading us to a fuller understanding of who we are as individuals.

So, then, who are you now and here?

Consider the stories that define who you are. Narrow your contemplation to those moments in which you derived a greater understanding of yourself. If possible, concentrate on a moment that revealed your relationship to your environment, or revealed aspects of your character that differed from the perceptions of those who perceived you. Or, following the lead of the Arctic Monkeys, recall a moment in which you could say, "Whatever people say I am, that's what I'm not."

**Assignment:** Write a personal narrative that recounts a moment in which you learned something about who you are.

Remember: your familiarity with the events in your tale can cause problems unless you remember to meet the demands of an audience that was not present at the events. Ask yourself the following questions:

- Does the narrator present and describe characters clearly? Do characters possess distinct characteristics? Is the identity of the narrator established?
- Does the story revolve around a central conflict? Is suspense developed? Is there a clear climax to the conflict?
- Is the story complete? Does it contain a clear beginning, middle, and end?
- Does the narrator reveal the specific setting clearly? Is the exposition (time and place of the action + introduction of major characters) sufficient?
- Are the journalistic questions (who? what? when? where? why? how?) answered clearly throughout?

- Are there sufficient and relevant descriptive details that would locate an audience in the narrative through their senses?
- Has the author used any figurative language (simile, metaphor, personification, symbol, allusion, etc.) effectively?
- Are grammatical transitions (between paragraphs) and dramatic transitions (in time and place) clear?
- Does the story mean anything? Can it yield a point, a theme? Is it stated explicitly? What is the rhetorical purpose in telling the tale?
