#### Big Ideas:

- The French colonists had different economic goals than did the Spanish and the English, and they used trade alliances and intermarriage with American Indians to acquire furs and other goods
- Competition over resources among European rivals led to conflict regarding colonial possessions and with American Indians
- o Great Britain began to strengthen its control over its colonial possessions in order to protect its empire
- British attempts to strengthen its control over colonial America sparked a colonial independence movement that would eventually lead to war
- As the French were removed from North America, attempts were made by American Indians to regain control which resulted in new white-Indian conflicts
